### **Exhibitor Terms and Conditions**

1. Sponsorship opportunities are designed to provide a showcase for products and services provided by service provider companies. Having an exhibitor or sponsorship relationship with FinCon does not indicate that FinCon or PT Money Conferences, LLC (owner of FinCon) endorses the products or services of the exhibitor or sponsor, hereinafter referred to as “Exhibitor”
2. Exhibitor agrees that FinCon shall have the right to make such rules and regulations or changes in arrangements, as it shall deem necessary and to amend the same from time to time. FinCon shall have the final determination and enforcement of all rules, regulations and conditions. It is understood and agreed that the Exhibitor shall abide by all the conditions, rules and regulations provided by FinCon for the governing of the Exhibit and the Conference of which it is a part.
3. Exhibitor agrees to accept this contract and agrees to enclose a check made payable to PT Money Conferences, LLC for the full amount due.
  - No rights in and to the said space (or any other space) shall vest in Exhibitor until this agreement has been fully accepted on behalf of FinCon, and such vesting shall thereafter be subject to the terms and conditions stated herein.
  - All exhibitor registration fees are nonrefundable.
  - No subletting, assignment or sharing of space will be permitted without FinCon approval and the payment of an additional fee.
  - Promotional activity is limited to the confines of the space assigned by FinCon. Advertising, canvassing and solicitation are not permitted

outside the assigned Exhibit Space except by Exhibitors that have been granted such space or rights by FinCon.

4. Space assignment will occur as registrations and payments are received, unless otherwise noted by FinCon.
5. Exhibitor's use of its assigned Exhibit Space shall not infringe upon the rights and privileges of other exhibitors.
6. Exhibitor is responsible for installing, maintaining and dismantling its exhibit.
  - One Exhibit Space includes one skirted 6' table and two chairs.
  - Exhibit Space set up may occur on Wednesday, September 21st, 2016.
  - Materials should be scheduled to arrive no less than 8 hours prior to set-up.
  - You may incur a hotel fee for incoming and outgoing exhibit materials.
  - Electrical service and addition booth needs are available, if requested prior to the event.
7. Exhibit Area will open on September 21<sup>st</sup>, 2016. Exhibitor displays must remain assembled through the open exhibit hours (to be determined by FinCon)
8. Insurance and liability are the sole and full responsibility of the Exhibitor. Exhibitor agrees to maintain such insurance that will fully protect FinCon from any and all claims of any nature, including claims under applicable workers' compensation acts and for damages for personal injury, including death, which may arise in connection with the operation of Exhibitor's display. Damage to inadequately packed property will be Exhibitor's own responsibility. In the event that Exhibitor damages the building, Exhibitor agrees to protect, save and hold harmless FinCon from all loss and/or damages whatsoever caused by Exhibitor to said building, or any part thereof, directly or indirectly. Damages or losses incurred by Exhibitor due to theft, pilferage, fire, accident or other causes shall be at the sole risk of the Exhibitor.
9. FinCon will arrange details and payment for sponsored events, meals, tote, lanyard and other materials. Sponsors are welcomed to provide input regarding the specifics of these items.

10. FinCon will not be liable for failure to hold the conference as scheduled. All payments made to FinCon will be refunded in that event.
11. Exhibitor shall abide by fire regulations and all other regulations of government agencies and the conference site. All draping and decorate material must be flameproof.
12. FinCon will not be responsible for delays or extra expense incurred because of strikes, labor disputes or any other cause beyond the control of FinCon, its agents or representatives.
13. Loud noises such as bells, sirens, buzzers, etc. will not be permitted. All Exhibitors must maintain a business-like atmosphere.
14. No activities shall be scheduled during the time of the official program hours, except with the express, written permission of FinCon.
15. Exhibitor hereby agrees to indemnify, protect, save and hold harmless FinCon, the conference center hotel and management from any and all claims, demands, suites, liability for damage, loss, harm or injury to the person or any property of the Exhibitor or any of its officers, agents, employees or other representatives.
16. Exhibitors or their representatives who fail to observe the conditions set forth by FinCon or who, in the sole opinion of FinCon conduct themselves inappropriately may be dismissed from the Exhibit Space with or without refund.
